Parents' and Carers' views 2023-24

This year we have asked for parental feedback from all parents via our annual online survey and face to face meetings at the end of EHCP meeting.

Summary

1. Online Survey

Most parents and carers (87%), who answered the survey, either strongly agreed or agreed with the given statements.

- This indicates that the vast majority of families are happy with the provision, care and education that is provided for their child at Breakspeare School.
- Note: there was a relatively high number of answers in the section 'I don't know'.
- **2. Face to face feedback at the end of EHCP** meeting took place with 95% of the families (some of our students' EHCP were pending and our new May/June starters haven't had their EHCP reviews at school yet).
 - The feedback was overall overwhelmingly positive and highlighted that parents think the school is important and successful part of their child's live.

Next steps the school will take in line with the given feedback

- Ensure that our wide enrichment offer is clearly communicated to the parents
- To use the online- questions as a prompt in our 'EHCP meetings' feedback section' to maximise opportunities to clarify necessary matters
- Further develop our 'school club provision' in different phases
- To continue to have two 'parent teacher consultation events' during the academic year, as established this year, to ensure regular communication of the students' curricula and progress
- To further develop communications via ClassDoJo when all classes are moving to use Class DoJo next academic year
- To start the Breakspeare School's Facebook Page to be able to share our wonderful students' experiences and activities at school within the whole community

We appreciate all comments and suggestions that were given, both online and during EHCP face-to-face / Teams meetings.

EHCP meeting feedback 2023-24

- i. Is your child happy at school
- Most of the parents and carers (98%) said that their child is happy at school
- ii. What would you like to include to your child's curricula
- Overall, most parents were very happy with our curricula offer and focus on development of independence, social skills and communication
- Vast majority of the parents think that important areas of the curricula are functional everyday living skills including transition to adulthood, enrichment opportunities both at school and in the community as well as maximising development in reading skills
- Some parents would like the therapy provision to be more frequent
- Some parents would like extended opportunities in history and IT
- iii. What aspects of learning and progress you have seen your child develop during last year
- All parents have noted their child progressing in their development.
- The parents were especially pleased with their child's development in self-regulation, communication, independence and lengthening engagement and focus in different activities
- iv. Have you had concerns and have these been responded promptly
- All parents apart from two said that their concerns have been responded appropriately and promptly. These matters have been addressed.
- v. Other feedback
- Some parents gave feedback on therapy service and transport
- A couple of parents wished more detailed feedback on their child's school day in homeschool diary or via DoJo
- Some parents expressed needing support with family support and care arrangements
